#### **Chief Complaint**

New patient referred here for right inflammatory breast cancer

#### **History of Present Illness**

69-year-old female presents today for evaluation of advanced right breast cancer. She was initially diagnosed in 2020 with an inflammatory breast cancer. Right breast skin biopsy 9/21/2020 showed-carcinoma in the dermis, consistent with mucinous adenocarcinoma.

ER 60% moderate

PR 2% strong

HER-2 positive 3+

She refused adjuvant chemotherapy. I was contacted by Dr. Hightower as she is interested in possible mastectomy due to a fungating wound of her right chest wall. She recently underwent staging scans and was found to have tumor which is fixed to the chest wall. She is also diagnosed with lung and liver metastasis. She was seen vesterday by radiation oncology who discussed palliative radiation. She is considering palliative chemotherapy.

69-year-old female with metastatic breast cancer with fungating right mass which encompasses the entire breast tissue and is fixed to chest wall. Due to the extent of the local disease, she is not a surgical candidate. This was explained to the patient and her husband at bedside. Recommend patient follow-up with me if mass decreases in size with treatment as she is considering both radiation and chemotherapy. She will follow-up with me as needed. Will discuss with Dr. Hightower.
